California - For many state financial aid programs - March 2, 2016 by midnight, Central Time.

Cal Grant also requires submission of a school - certified GPA by March 2, 2016. Applicants are encouraged to obtain proof of mailing their GPA and to retain a copy of their GPA form. For additional community college Cal Grants - September 2, 2016 by midnight, Central Time. If you are a non-citizen holding a Social Security card issued through Deferred Action for Childhood Arrivals (DACA) or for some other work authorization, you should fill out the California Dream Act Application found at www.caldreamact.org. Do NOT fill out a FAFSA. Contact the California Student Aid Commission, www.csac.ca.gov, or your financial aid administrator for more information.

College Deadline

Check with the college(s) you are interested in attending. You may also want to ask your college about its definition of an application deadline - whether it is the date the college receives your FAFSA, or the date your FAFSA is processed.
